


2018 Licking County 4-H Cloverbud Day Camp

Parents/Guardians: Please complete the information below and return with the registration by May 18, 2018.

I understand that my child, _____, will be participating in Licking County 4-H Cloverbud Day Camp on June 16, 2018 and give my permission for him/her to do so.

I give The Ohio State University, OSU Extension, the Ohio 4-H program and 4-H Camp Ohio permission to publish in print, electronic, or video format the likeness or image of my child. I release all claims against the University with respect to copyright ownership, any personal or proprietary rights, and/or publication including any claim for compensation related to use of the materials.

I understand and accept that it is my responsibility to arrange transportation to and from camp for my child.

Activities at camp will include swimming, nature hikes, campfire activities, dances, relay races and other recreational games. I understand that participation in this activity is strictly voluntary and is not a requirement of 4-H membership.

I am aware and have discussed with my child that:

- A. Participants are expected to follow instructions of adult chaperones/4-H professionals throughout the course of the camp and remain part of the entire group, unless given specific instructions otherwise;
- B. Participants are expected to fully participate in activities outlined by the 4-H staff;
- C. Participants are expected to follow the camp behavior guidelines and respect each other, sites that they visit, and people that they may come in contact during the workshop;
- D. Being in and around water, woods and participation in camp activities may cause clothing to become wet, dirty and beyond cleaning and/or repair.
- E. Hiking may give rise to risk of injury arising from the surface or subsurface of the ground on which the hiking occurs;
- F. Participation in sporting/recreational events may give rise to injury as a result of collisions with another individual or sudden falls;
- G. Other participants may act in a negligent manner which otherwise may result in harm to my child;
- H. Swimming may lead to injury caused by slippery surfaces, contact with other swimmers and/or objects in the water.

I understand that my child is not required to participate in this activity, but grant permission for him/her to do so, despite the possible risks. I recognize that by participating in this activity, as with any activity involving motor vehicle transportation and interaction with unfamiliar surroundings, my child may risk personal injury. I hereby attest and verify that I have been advised of the potential risks, that I have full knowledge of the risks involved in this activity, and that I assume any expenses that may be incurred in the event of an accident, illness, or other incapacity, regardless of whether I have authorized such expenses.

In consideration of the opportunity for my child to participate, I, acting for my child, myself and our respective heirs, executors, administrators and assigns, agree to assume any and all risks associated with this activity and release, indemnify and hold harmless OSU Extension, 4-h Camp Ohio, the Ohio 4-H program and The Ohio State University, its Board of Trustees, employees, agents and/or any of its representatives for any claims, loss, damages, or injury resulting from my child's participation in activities.
