Market Steer / Market Heifer Weigh-In

- WEIGN-IN:** **Saturday, December 11, 2021 (8:00 a.m.—11:00 a.m.)**
West End of Grubb Arena, Hartford Fairgrounds

* If you are participating in the AGR Holiday Classic that same weekend, and need to weigh prior to attending the show, please contact Ian (740.973.5629) or Kody (740.4040.3676) to make arrangements.
- TAGS:** **We will using Electronic Identification (EID) tags in 2022.**
If the calf does not already have a EID tag in place upon arrival to weigh-in, one can be purchased.
- Exhibitors are encouraged to acquire their own tags, prior to weigh-in at the fairgrounds.

 - EID tags administered by the OCA Best Program, Knox / Delaware County Fair or other affiliated programs or producer are acceptable.
 - Any exhibitors who do not have EID tags in advance of arrival, must purchase tags at cost of \$5 per animal.
 - Each animal may only have one EID tag; it is also unlawful to remove an EID tag once it has been placed in the animal's ear. It is intended for lifetime tracking.
- DNA SAMPLES:** **Hair samples will be collected on each calf, as a means of identification beyond the recorded EID tag. Tattoos will not be administered.**
- BRED/OWNED:** **If your steer / heifer qualifies for the Bred & Owned class, meaning that the exhibitor owned the cow at the time that she was bred, and at the time that the calf was born, you will need to designate this during online registration for weigh-in.**

2022 OHIO STATE FAIR

Market Steer / Market Heifer Identification Process

IDENTIFICATION: In order for a Market Steer / Market Heifer to be eligible for entry to the 2021 Ohio Sate Fair, the appropriate DNA Sample and Identification Envelope must be submitted by no later than January 15, 2022.

OFFICIAL ENTRY: **Submitting DNA sample materials by the stated deadline makes those animals eligible for official entry to the Ohio State Fair, entry forms must be submitted prior to June 20, 2022.**

DNA PACKETS: **DNA packets can be obtained at your local Extension Office.**
NOTE: Packets are NOT available through the OSF Office in 2022.

Packets are available in two options. Please notify the office which option is needed when you contact them to request a packet for each market steer / heifer.

- Option #1: The steer / heifer already has an EID tag, you only need the DNA Packet with instructions.
- Option #2: The steer / heifer does not have an EID tag, and you are in need of both an EID Tag and DNA Packet with instructions.

SIGNATURE: **Please be aware that your county 4-H Youth Development Educator or FFA Instructor will need to sign each DNA envelope prior to submission as notification that you plan to enroll in the 4-H / FFA Market Beef project for 2022.**

In order to be eligible for entry in to the Market Steer / Market Heifer classes during the Ohio State Fair, you must officially enroll in the Market Beef project through your 4-H or FFA program. Neglecting to do so will forfeit the ability to make entry to these classes. (Same rule applies to entry in county / independent fair market classes)
